**Conservation District/Agency/Watershed Association reports** (All present):

Those in attendance reported on current and future activities within their respective organizations that relate to WPCAMR interests.

- Jim Resh is retiring but would like to remain Indiana CD Delegate and WPCAMR Secretary. Indiana CD is just finishing up the Bear Run Renaissance. They are trying to figure out the best way to optimize left over funds, for which they are looking at cleaning up boney piles and establish a trust.
- Robb Piper reported that a senior environmental corps has been established and is starting to sample.

- Amy Myers noted that Allegheny CD is working to monitor discharges coming off of Mt Washington. They are in the middle of strategic planning. They are doing a dam removal which should improve diversity.
- Gordon Snyder noted that Jefferson CD lost access to a treatment system that is great need of maintenance. They are working on getting grants for Sugar Camp. There is a bond forfeiture on a slurry pile that nothing has been done on.
- Jared Zinn noted a project that Greene CD is involved in.
- John Graffius of Blair is a new intern.
- Pam Milavec reported that they are closing in on 60% design for a very large treatment plant. It will take care of Cresson 9, Galiston Shaft and Argyle stone bridge. There will be a public meeting soon. They will be drawing down mines pools to stop discharges, which will take water from residents. They will be supplying city water to them at no cost. Phase I of the Weirum project is starting which will eliminate the Vintondale bore holes and restore the main stem of Blacklick Creek. They are working on a QHU for Little Conemaugh by mid summer. The setaside has been impacted by a reduction in grants coming from OSM. DEP has 50 passive systems. If there is no re-authorization, how to they continue OM&R of these systems? They are looking for ways to continue. Growing Greener grant round is open and closing on July 11. Dave Leifert is the contact for mining-related projects.
- Jim Eckenrode has an MS4 program to evaluate the remaining AMD in the county and the existing systems.
- Ron Horansky is working with grantees to turn in grant contract requirements. He recommended that Jefferson call Knox office to discuss the bond on the slurry sight.
- Dean Baker reported on Ernfeld in Cambria County. Lankashir switched from Lime to peroxide to save cost.
