#### WPCAMR BUSINESS MEETING:

# Secretary's Report (Amy Miller):

Review of past meeting minutes with the correction of spelling errors. Motion (Dryzal/Williams) to accept the August 2019 minutes. Passed.

# Special Presentation: Live Stream of House Committee on Natural Resources, Energy and Mineral Resources Subcommittee Hearing on HR 4248 and the AML Fund

**PA DEP BAMR Update:** Eric Cavazza shared that the new round of PILOT is accepting applications. The Cresson plant is experiencing issues that are not yet resolved. The expected AML grant for this year should be around \$37 million. Eric noted a lot of other reclamation and watershed improvements across the state that they were involved in. A lot are in western PA and a few in eastern PA. There were 127 emergencies in 2018. The number of emergencies is related to the precipitation. So far this year we have had 80, about \$2.2 million and probably another \$1 million will get spent on emergencies.

#### **NEW BUSINESS**

Conservation District/Agency/Watershed Association reports (All present):

Those in attendance reported on current and future activities within their respective organizations that relate to WPCAMR interests.

- Jared Zinn shared the projects that Greene County is involved in
- Amy Miller discussed what she is working on in Allegheny County.
- Chelsea Walker is working to rehabilitate the Booker Discharge. They had a Quick Response. She is also hopeful of a new Growing Greener grant with Sewickley
- Kelly Williams announced she will get a very large grant to work on the largest discharge in Morgan Run. In Deer Creek, they have found young-of-the-year trout finally, after building a large treatment system.
- Jim Eckenrode talked about a feasibility study that may get proposed for Growing Greener. He is working in a couple different counties for some sampling. Jim offered to have students look at data.
- Bob Sabo is the new Watershed Specialist for Indiana. Brooke noted that they will be sampling 35 sites this coming weekend on Yellow Creek.
- Maria Sorce shared that Armstrong county is wrapping up the Kimmel discharge. They are working on Silver Rock sites.
- Tim Hummel talked about Venango and the watershed groups. South Sandy Watershed meets quarterly but Tim doesn't know when their meetings are. Scrubgrass Creek Watershed works with Venango CD well. They have a project in Bullion Run. They are writing a River Conservation Plan. They found some additional AMDs.
- Dave Lieford shared that Growing Greener is due Dec., 20. About 25% should come to AMD projects.
   If your watershed is in an QHUP, you are encouraged to put in an application for the set-aside program.
   Not all of the money was spent yet. Malcolm Crittenden's replacement is DJ\_\_\_\_\_. Ron Horanky's
   replacement is Ron Parr. Jeff Fliss also retired and Stewart Demansky is taking his place for the time
   being. Donna Wagner is putting out a survey on passive treatment systems. We are encouraged to
   complete the survey. Some money may come in for OM&R as a result of the survey.
- Jackie shared that they are applying for a project in Little Conemaugh. They also helped with a fish survey and found a rainbow trout and a few fish of interest.
- Diane Thomas continues with stream monitoring and Dirt and Gravel roads. They would like to do some live monitoring.
