#### **PA DEP Update (Pat Webb)**

Pat discussed potential changes to IJJA and what that means for PA. Pat noted that the government shutdown is impacting work somewhat, but emergency response continues. Lanny Erdos was confirmed as Director of OSMRE.

Joe and Cindy gave an update on the subaward program. Cindy shared that 78 grants have been awarded to date, two of which still need ATP. They received 22 applications for this round and are waiting to be scored. Guidance is out for 2026.

Pat continued that there has been an uptake of AML in-house projects for BAMR in this last year.

#### **Partner Updates (All present)**

- Ben at Indiana CD is wrapping up a watershed assessment. He is awaiting a 30% design for Bear Run.
- Chelsea is working on Bovar Pile and is considering soil amendments. They are hopeful to submit an application for construction in the spring. Chelsea is reviewing the bids for design at Irwin Discharge.
- She is working to close out a grant at Lion's Run. She will be putting out a bid for another passive treatment system soon.
- Elk County will be complete at West Creek in the next month. They will be submitting to for the WCAP reimbursement soon. Elk is also sampling in Dentz Run.
- Jeffrey is helping Racoon Creek do some sampling that is AMD related.
- John noted that GAI was awarded a couple design bids for BAMR including Shawville, Hanover, and Allegheny Portage Historical site. He may bid on the Indianola project.
- Cambria closed out the WCAP project and a sub award grant for a refuse pile.
- Jefferson is looking to apply to GG for Mill Creek in the spring.
- Shane finished up a construction project and Quick Response helped with that. He is wrapping up two watershed assessments, one with BAMR assistance. They got a GG grant extension for Little Coon. Shane thanked the PA AMR Conference for the scholarship. Shane is also trying to characterize a bond forfeiture discharge in Mill Creek.
- Maria is working with BAMR to repair Darmac 14. She wants to prevent Beaver damage. She is doing sampling with Stream Team.
